Patricia Gray, Talks about Day of Remembrance cancellation

Apologizes for cancellation with Tsuru for Solidarity

Said messages and strategies around resistance, two different goals

Find ways to be strong advocates

Bob M talks about letter they sent. Supported cancellation. Strident, assertive organization. Do it outside Federal courthouse or City Hall.

Bruce, 501c3 statement and Tsuru for Solidarity

Emily, do what we can to protect our people.

Patricia, we are set up to help and protect. Go to Market Commons. At our core, our mission is to keep people safe.

Kim Ramirez and Chris Pink, owner of Can Can, motivated to do something in response. Some sort of community reaction. A thousand cranes, stories of farmers.

Andrew, Current administration has radical, sadistic agenda. If you issue a statement in solidarity, it can blow back on you. Will be seen as hypocrisy.

Rachel, PDA says on 2/19 going forward, this will be part of the PDA - embracing and honoring and remembering DoR. Been working with JA leaders in the community. This is a tremendous opportunity for us to learn, heal and repair.

Chris Pink, crafting a letter that we hope will be supported by Market vendors.

6:40 p.m. Zack Cook, PDA Director of Programs, Daystalls rules

Talks about daystall rules process, 38 proposals this year. 21 came from crafters, 2 from buskers, 1 general, 5 farmers and 9 staff.

Talks about public feedback session that was held a week and a half ago. Can still send in written responses until 2/25.

Farm rules. While our bar needs to be set higher than other locations, there should be some analysis and wiggle room. We used to say you had to grow and value add yourself. Now you can use a packer as long as it's your ingredients and recipe.

How many buskers? Over 100, Alex says. Handful of stable buskers, but want to reach out to buskers who didn't come back and ask why.

Outreach Committee— Are You Market on 3/10. Emily will be there. Might have brochure ready. Daffodil Day on 3/20, any volunteers to set up a table?

Budget, Bruce talks about online registration, emails, SEOs.

Pike Place - updates

Chris Weaver, haven't heard about safety. People committed vehicular manslaughter on several occasions recently. Don't want to be the one who says I told you so. We need to do something. Bob M. says PDA met with SDOT about fixing street.

Zack, first of several meetings. Pointed out asphalt patches, deteriorating curbs, sloping sidewalks and other things that need fixing. Walked with SDOT street use people. A lot of issues

are on the utility side. With World Cup coming in two years, there is a lot of push to fix things up just like before MLB All Star game a couple of years ago.

Graham, So far Constituency has said PDA should have control but we haven't said what we want to do with that control. We do have opportunity and maybe obligation to make a more nuanced statement.

Emily, Add discussion bylaws about limits of advocacy work.

Gina, noise ordinance, writing letter to make noise amplification illegal throughout downtown. Constituency might want to take up this cause.

Mentions rummage hall situation, says it's very strange. New space is hard to find and very small. Make them load up every night.

Chris, rummage hall is a requirement in the Charter. It's in old Market News office, which is too small.

Austin, new newspaper for the Market. Says thank you for it. Good contribution.
